- 4) Political Committee Report: a) Prop 30 passed. Prop 32 failed. Prop 37 failed. b) There are a number of dissatisfied CTA affiliates at the community college level, who are dissatisfied with CTA and looking for new representation.

- 4) Set times for the Spring: We will be formally setting the schedule for Spring on our first meeting in January when we know better what our schedules will be.
