Anne moved and Mark seconded that the agenda be adopted with flexibility.

APPROVAL OF MINUTES

Bill moved and Cecil seconded approval of the November minutes. They were approved by general consent.

OLD BUSINESS

- A) Member Issues Issues with the Testing Center under the supervision of Gerald Helm. Complaints have been made by lab supervisors that 1) student workers are handling and processing tests at front desks, which is a violation of privacy policies 2) lab supervisors have never seen such un-professional conduct in this area and are concerned that Mr. Helm hasn't the training to conduct department business in a proper way, potentially harming their own reputations. 3) The complaint of the day seems to dictate how the center is run. 4) Employees are ordered about in an entirely disrespectful way. The area dean needs to be notified for further action on this. There is no contract violation which leads to frustration on the part of union officers in addressing these issues.
- B) Negotiations: Linda submitted a confidential written report.

In his interview with the Executive Council, Newsom presented a strong progressive vision for our state anchored by fully funded and supported public schools. He also has a strong track record of public service as lieutenant governor of California and former mayor of San Francisco. Other endorsements include: Dave Jones for Attorney General, a dual endorsement of Ed Hernandez and Eleni Kounalakis for Lieutenant Governor, and Fiona Ma for Treasurer, Ricardo Lara for Board of Equalization.

PRESIDENT'S REPORT

Linda submitted a written report that included the following meetings:

Academic Senate

Meetings of November 6 & 29

Linda didn't attend the 11/6 meeting but was informed that no actions were taken.

At the 11/29 meeting there was discussion about Guided Pathways and the Citrus College Promise Program. No action items were voted on. However there is concern over a lack of attendance by senators.

President's Steering Committee Meeting

Meetings of November 6, November 27

Linda didn't attend the 11/6 meeting.

At the 11/27 meeting the committee voted and passed the Financial Resources Program Review Funding Requests of \$14,130.75. Ity was noted that there were only a few requests submitted. The music department submitted (and received) a request for \$5400 for a saxophone. This was the most expensive request. The committee was given an overview of Guided Pathways. The program is mandated by the Chancellor's office and the funding is for administrative use.

CFT Executive Council

The CFT Executive Council met December 1 & 2 in Burbank. Gubernatorial candidates Gavin Newsom and Antonio Villarogosa were interviewed. The council deliberated the choices and the strategy of our choices for Governor.

The Executive Council spent many hours discussing our Strategic Plan and what our next steps are going to be in terms of reorganization, staffing and budget cuts.

The "College for All" initiative was discussed during the COPE meeting. It needs 585,407 signatures by April 24, 2018. The campaign "Make College Free Again" will have 19 "kick-off" events around the state to get volunteers to gather signatures. It will be offset by an estate tax on the wealthy. Another initiative to be considered is the "Great Teachers, Better Schools" initiative by mark Leachman. It will focus on raising teacher's salaries so that it matches legislator's salaries through a 2% sales tax increase and would be exclusive to teachers. (This was met with some disagreement from other educators in CFT.)

Also discussed were the other elective positions we will be supporting. The CFT Convention theme this year is "Fight for Your Rights" (ala the Beastie Boys). It was also approved to change the threshold from \$42,000 to \$45,000 for the regular rate per caps, but no change for other levels of per caps.
