CFT Part-Time Committee

The Committee met on Saturday, February 3, 2018 at Mission College in San Jose. The topics discussed were: a) Rehire Rights, (what was negotiated at each college so far). b) Age and Experience Discrimination. c) Membership Engagement and how many members have reaffirmed their membership, maintenance of membership - (all but Cabrillo and Citrus have it in their contract). d) How many adjuncts serve in executive positions in wall-to-wall locals - (John Govsky will create a survey). e) "Drop" campaigns - (where outside interests try to get members to drop their dues and membership). f) "Spring Action" and Lobby Days. The committee has a group where items and handouts can be placed. g) The committee decided to have two workshops at

the CFT convention: adjuncts retirement and adjunct health care. Both will be panels to discuss members issues.

Legislation

Linda provided a list of pending legislation for the 2017-18 year before the California State Legislature. Of particular interest were two Assembly Bills presented by Jose Medina: AB 204, Community Colleges: Waiver of Enrollment Fees which amends and existing law requiring community college districts to charge each student a specified enrollment fee and consider a process for reestablishing fee waiver eligibility. Provides for the minimum academic and progress standards. Requires the Office of the Chancellor to review each community college district's due process procedures, including any subsequent modifications of the procedures, adopted to appeal the loss of a fee waiver, and comment on the procedures. Provides for equity plan. AB 310, Part-Time Faculty Office Hours which requires each community college district to report the total part-time faculty office hours paid, divided by the total part-time faculty office hours taught during the prior fiscal year and post this information on its internet Web site.
